TECHNICAL EDUCATION - Common Entrance Examination for Polytechnic admissions for the Academic Year 2000-2001 - Providing of 3% horizontal reservation to Physically Handicapped candidates for Diploma in each category of Engineering/Non-Engineering namely Open Competitions/Backward Classes in all Groups (A,B,C&D)/Scheduled Castes and Scheduled Tribes - Orders - Issued.

ORDER:-

In the reference 1st and 2nd read above, Government have issued rules for admission into first year Diploma in Engineering Courses/through Common Entrance Examination for Polytechnics. In the said rules Government have provided 0.5% reservation to the Physically Handicapped Category candidates.

2. In the reference 3rd read above, the Government have also issued orders on priorities to be adopted in respect of "Other Categories" under Physically Handicapped Category for admission into Diploma Courses in Polytechnics.

3. The Chief Secretary to Government has convened a meeting on 6-3-1999 for providing 3% horizontal reservation to Physically Handicapped Category candidates in Engineering courses and also in view of the Act, proposal has been submitted to Government to amend the rules of admissions into first year under Graduates professional courses issued G.O.Ms.No.184, Education Department, dated 20-08-1993. Accordingly Government have issued orders in G.O.Ms.No.339, Education Department, dated 15-12-1999 amending the rules of admission issued in G.O.Ms.No.184, Education Department, dated 20-08-1993.

4. The Commissioner of Technical Education who was consulted in the matter has proposed that 3% reservation for Physically Handicapped for admission into Polytechnic Diploma Courses may be provided horizontally in each group i.e., Open Competitions, Backward Classes, Scheduled Castes and Scheduled Tribes in the following cyclic order:-

- (i) 1% for visually handicapped.
- (ii) 1% for hearing impaired.
- (iii) 1% for Orthopaedically Handicapped.

The above reservation shall not be applicable for the candidate with following defects:-

- (a) Mentally retarded.
- (b) Blindness.
- (c) Deaf and Dumb.
- (d) Chronic heart, lungs, kidney, liver diseases.
- (e) Muscular Dystrophy.

5. The Commissioner of Technical Education has requested the Government to issue the suitable amendments to G.O.Ms.No.146, Education Department, dated 13-07-1988 read with G.O.Ms.No.241, Education Department, dated 20-10-1993 i.e., rules of admissions of candidates into First Year Diploma Courses in Polytechnics and State-wide Institutions.

6. Accordingly Government hereby issue the following notification. It will be published in the next issue of the Andhra Pradesh Gazette, dated 25-09-2000.

NOTIFICATION

In exercise of the powers conferred by Section 3 read with Section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Professional Educational Institutions (Regulation of Admission into Undergraduate Professional Courses through Common Entrance Test) Rules, 1993 issued in G.O.Ms.No.146, LEN & TE (TE-1) Department, dated 13-7-1988 published in rules supplement to Part-1 issue of the Andhra Pradesh Gazette dated 25-09-2000.

AMENDMENT

In the said rules, under the heading: "1. General Reservation" in Annexure-I, for item (iii), the following shall be substituted:-

(iii).3% reservation horizontal for Physically handicapped in each group i.e., O.Cs, B.Cs, S.Cs, and S.Ts in the following cyclic order.

- (i) 1% for Visually Handicapped.
- (ii) 1% for Hearing impaired.
- (iii) 1% for Orthopaedically Handicapped.

Note:(1): The above reservation shall be rotated in cyclic order as follows:

- (a) If candidates in Visually Handicapped category are not available the vacancy can be filled up by the candidates in the category of hearing impaired.
- (b) In case of the Hearing impaired candidates are not available, the vacancy can be filled up by the candidates in the Orthopaedically Handicapped Category.

Note:(2): In case, qualified Physically Handicapped candidates are not available for any category among the three categories mentioned above, the unfilled vacancies shall be filled with other candidates on the basis of merit in the respective category i.e., OC/BC/SC/ST.

Note:(3): The reservation of 4% (0.5%) which is cancelled shall be left for Open Competition.

Note:(4): The candidates with the following defects shall not be eligible for admission into Diploma Courses in Engineering/Non-Engineering and also Pharmacy Courses:-

- (a) Mentally retarded.
- (b) Blindness.
- (c) Deaf and Dumb.
- (d) Chronic Heart, Lungs, Kidney, Liver diseases.
- (e) Muscular Dystrophy.
